Purpose of the role

The post holder will be responsible for tissue culture support in the group of Prof. Gabriele Kaminski Schierle. Your principal activity will be to provide experimental support to the group and coordinate the cell culture activities, maintain cultures, freezing cells, making buffers and media. You will also be responsible for coordinating and maintaining group safety record keeping, ordering consumables and responsibility for lab organisation.

Key responsibilities

- Provide support for research projects. Design, develop and modify experimental protocols and techniques from general verbal instructions, prepare and collate results for interpretation by self and others, use results to make changes to experiments. Carry out experimental work under the instruction of PI as part of research projects. Contribute to the design of research experiments and collate results.
- Provide technical advice to research students and researchers in the design of experiments or sample analysis. Advise on solutions, sample preparation analysis methods that could be used, taking into account

time and financial constraints.

- Maintenance and running of the research laboratory. Instruct research students in the correct application, use and maintenance of equipment, laboratory procedures (e.g. correct safety procedures in handling research equipment) and routine experimental techniques. Ensure the laboratory has adequate stocks of sterile media, disposables and equipment.
- Operate and maintain general and specialist laboratory equipment including analytical instrumentation plus centrifuges, autoclaves, water purifiers, glass washers etc. Maintain pH meter and stock solutions.
- Keep records of maintenance.
- Maintain cleanliness and organization of microbiological safety cabinets.
- Monitor the condition of refrigerators and freezers and stocks within.
 Demonstrate and provide training in routine cell culture and molecular biological techniques and procedures following established protocols.
 Record and interpret data and present the findings.
- Provide technical advice and contribute to the design of experiments.

Key responsibilities (continued)

- Liaise with the departmental safety officer to ensure codes of practice and relevant safety regulations are implemented and observed within the research laboratory, carry out risk assessments.
- Organise the disposal of chemical and biological waste from the group, including liaison with the University Safety office and the disposal contractors. Keep records of waste disposal.
- Assist research workers and Part IIB students in their work, particularly to ensure their safety. Advice on the selection and safe use of chemicals and biological materials.
- Keep standard operating procedures, Material Safety Data sheets and protocols up to date.
- Responsibility for the maintenance and repair of equipment. When unable to repair equipment, liaise with relevant companies and oversee repair or replacement.
- Provide guidance to staff, researchers and students on experimental and analysis techniques, introduce new staff and researchers to health and safety procedures within the laboratory.
- Train users in the safe operation of equipment. Develop and demonstrate experimental techniques to researchers.
- Supervise and assist researchers in the tissue culture facility to ensure best practice and to ensure their safety.
- Keep records of all training given to staff and students within the group.
- Monitor laboratory resources including, expenditure within a set budget, source new suppliers, place orders for consumables, and equipment when required, process invoices and delivery notes.

 Purchase stocks for the lab and individual pieces of apparatus. Maintain stock of general chemicals and gas supplies in research laboratories. Monitor chemicals and storage, catalogue chemical stocks.

Department of Chemical Engineering and Biotechnology



The Department of Chemical Engineering and Biotechnology at Cambridge has an international reputation for advancing molecular science and technology at the boundaries where chemistry, physics, mathematics, and biology meet. It is setting the pace for scientists, engineers, industrialists, and entrepreneurs to solve a range of complex global challenges across energy, the environment, and healthcare.

The Department has forged a number of significant industry partnerships and has pioneered the commercialisation of its cutting-edge research, recognising the vital relationship between knowledge transfer and economic growth.

The quality, depth and breadth of the Department's teaching have received international acclaim. Its training produces graduates of exceptional calibre with the vision and flexibility to apply their skills across a variety of fields and sectors, from commerce and high finance to industry and medicine.

Key information

The Department operates on the West Cambridge site. The department houses 30 academic, ~50 academic-related and assistant support staff, ~75 post-doctoral workers and ~150 research students. There are also ~50 MPhil students and ~150 undergraduates. The Department's research income was over £8.9 M in 2021-22. The department currently ranks 5th in the world in its discipline, and 1st in Europe (QS University rankings), and came second in the latest UK Research Excellence Framework Exercise (REF 2021).

The School of Technology

The School of Technology is one of the six Schools in Cambridge. It comprises: the Department of Engineering; the Judge Business School; the Department of Chemical Engineering and Biotechnology; the Department of Computer Science and Technology; and the Cambridge Institute for Sustainability Leadership. The School employs over 1,500 people and has a student population of nearly 3,300 (between undergraduates and postgraduates).

About the School Office

The School Office interfaces with a number of institutions both externally and internally, such as the EPSRC and the central administration. It has especially close contact with the Academic Division, Finance Division, the Research Office and Human Resources Division as well as the Departments within the School.

It is responsible for proposing, consulting and implementing School-wide polices and administrative procedures, ensuring compliance within the general governance framework, and financial control.

Governance

The School of Technology Office is responsible for a large number of School-level committees which in turn support the decision-making at the Council of the School, the School's governing body.

The Head of School together with the Heads of Department work together to drive the strategic planning for the School including all teaching, research and operational activities which are funded by all sources of income, for approval by the Council of the School. What we do:

• Finance: Supporting financially-informed decision-making and planning within the School and ensuring Financial Regulations and other policies and procedures are implemented and maintained at Departmental level. Providing support and advice to Departments on financial matters, accounting processes and procedures relating to the use and management of the University's Finance System. Key link with the Finance Division.

• **Research:** Responsible for the development and management of School-wide policies and initiatives to improve research grant income and application success rates in the School.

• Education: Coordinating activities to support undergraduate and postgraduate education in the School through its Undergraduate Committee and Graduate School Committee. Responsible for addressing strategic education issues. Supporting a range of Doctoral Training opportunities including the Centres for Doctoral Training and ICASE awards both funded by the Engineering and Physical Sciences Research Council (EPSRC), as well as the WD Armstrong studentship awards.

• Human Resources: Supports management and staff by providing HR management information; case support; guidance on the application of HR policies and procedures. The HR Business Manager takes the lead on significant HR projects and complex employment issues.

Terms of Appointment

Tenure and probation

Appointments will be made on a fixed -term basis (2 years), this is because your employment relies on the availability of finite funds for a specific purpose that are not part of the University's general revenues. Appointments will be subject to satisfactory completion of a six-month probationary period.

Hours of Work and Working Pattern

The hours of work for the position are 100% of full-time / 36.5 hours per week, working Monday – Friday. We welcome applications from individuals who wish to be considered for part-time working or other flexible working arrangements.


Working at the University
